A paraphrase is a restatement of a text in another form or other words, often to simplify or clarify meaning. "When you paraphrase," says Brenda Spatt, "you retain everything about the original writing but the words."

Paraphrasing involves putting a passage from source material into your own words. A paraphrase must also be attributed to the original source. Paraphrased material is usually shorter than the original passage, taking a somewhat broader segment of the source and condensing it slightly.

v Paraphrase, don't copy. Restate the idea in your own words. Make sure to give an in-text citation for the use of the idea. v Understand the subject matter before writing your paper. If you are unclear about the subject, you are more likely to rely on the exact wording of the author.

### When does paraphrasing become plagiarism

Here, paraphrasing is defined as: finding the exact sentence or passage that is relevant to your own paper, lifting it out of the source, switching out a few words for synonyms or re-arranging the words a bit, and dropping the resulting sentence or passage in your paper. Paraphrasing of this sort is actually considered plagiarism in psychology.
