A health reimbursement arrangement, or HRA, is an IRS-approved health benefit that allows for tax-free reimbursement of medical and insurance expenses. To be compliant, it must follow certain requirements—including having formal plan documents in place.. HRA plan documents describe the benefit’s terms and conditions related to the operation and administration of the benefit.
