The Law also amends the Code of Judicial Organization. It states that specially designated Tribunaux de Grande Instance (courts of general competence) will be competent to hear cases on the enforcement of intellectual property rights. Infringement is punishable by a maximum penalty of three years of imprisonment and a €300,000 fine (about US\$441,000).

Contrary to the position in most Common Law jurisdictions, the breach of proprietary rights is a criminal offense in France: contrefaçon (Arts. L335-2 to L335-4). This attracts a fine of up to 300,000 Euros (approx. US\$391,850, or £250,300 as of January 2012) and a term of up to three (3) years imprisonment.
