(13) Jurisprudence exam--An open-book examination made up of multiple-choice and/or true/false questions covering information contained in the Texas Physical Therapy Practice Act and Board rules. (14) On-site supervision--The physical therapist or physical therapist assistant is on the premises and readily available to respond.

Applicable fees are paid directly to the third-party vendor for the jurisprudence examination.
